Generally, you must pay all the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u>?	Yes. Well-child care, in- <u>network</u> <u>preventive care</u> , in- <u>network</u> independent labs, in- <u>network</u> outpatient/office services for mental health/substance abuse, in- <u>network</u> prosthetic limbs and services subject to office visit/ <u>urgent care</u> , drug card and outpatient <u>copayments</u> . The In- <u>Network</u> health and drug card out-of-pocket maximum amounts accumulate separately.	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. If you have other family members in this <u>plan</u> , they have to meet their own <u>out-of-pocket limits</u> until the overall family <u>out-of-pocket limit</u> has been met.

Does this plan provide Minimum Essential Coverage? Yes
